



## **Tong Chong Street Market x KIN Food Halls: Beer Festival 2022**

### **EVENT & TICKET TERMS AND CONDITIONS**

Set out below are the terms and conditions relating to your attendance at “**Tong Chong Street Market x KIN Food Halls: Beer Festival 2022**” to be held in Hong Kong from 20 October to 22 October 2022 (the “Event”) at KIN Food Halls, located at 2/F Devon House, Taikoo Place, 937 King’s Road, Quarry Bay (the “Venue”) and organized by Taikoo Place and KIN (the “Organisers”).

By purchasing a ticket and entering the Venue, you hereby agree to the following terms and conditions:

1. All tickets are non-refundable.
2. All tickets cannot be re-sold. Anyone found to be reselling their tickets will have their tickets cancelled.
3. All tickets are unique to each attendee, and duplicate tickets will be refused.
4. Those under the age of 18 will not be admitted into the Venue. The Organisers reserve the right to demand proof of age in the form of your Hong Kong Identity card, passport or other forms of proof of identity acceptable to the Organisers.
5. To be admitted into the Venue and attend the Event, you must comply with the vaccination requirements in the Vaccine Pass scheme, and have received the third dose after 6 months from the second dose, or have received the second dose within 6 months from the first dose; only those holding an Exemption Certificate issued by a doctor will be exempted.
6. All persons wearing "compulsory quarantine" hand straps or Vaccine Pass holders with a Red and Amber Code will not be allowed to enter.
7. Upon arrival, all staff and guests are required to present a vaccination record, proof of a negative rapid antigen test (RAT) result obtained within 24 hours and scan the LeaveHomeSafe App venue QR code. Please mark your RAT result with your name and the date and time of the test. The Organisers reserve the right to refuse entry of any persons who do not comply with the requirement.



8. To enter the Venue and attend the Event you must wear a face mask or facial covering that covers the chin, mouth and nose; Masks must be worn at all times when not consuming food or beverages.
9. The Organisers may implement crowd control measures based on the number of attendees.
10. You are required to follow the social distancing guidelines by maintaining a minimum 1.5m distance between each group; groups are limited to a maximum of eight persons.
11. To be admitted to the Venue and attend the Event, you must have a valid Ticket.
12. Upon admission to the Venue, you will be stamped with a session-specific UV stamp on your hand. Those who fail to present the session-specific UV stamp will not be readmitted.
13. The ticket you have purchased is for the Event and the Organisers reserve the right to alter or change the programme, line up and offerings without prior notification.
14. The Organisers reserve the right to cancel the Event at any stage, if deemed necessary in their sole opinion, or if circumstances arise which are outside their control, including but not limited to pandemic restrictions and adverse weather conditions. Guests are advised to check Tong Chong Street Market's Instagram <https://www.instagram.com/tcsmarkethk/> before their visit. If the Event is cancelled or there are any changes to the line-up, the Organisers will not be liable for the payment of any compensation or any loss of money and/or expenses incurred. In the event of the cancellation of the entire event only the face value of the ticket will be refunded through the ticket agent through whom the tickets were purchased.
15. No outside food, alcohol or soft drinks may be taken into the Venue.
16. The Organisers adopt a zero tolerance to drugs and as such all drugs, including legal highs are prohibited from the Event and Venue. You may be refused entry or removed from the Event and reported to the police if found to be in possession of any such substances.



17. The following articles are prohibited at the Venue and the Event:- illegal drugs or substances, knives or similar weapons including chains/chain wallets, fireworks, explosives, lasers and laser pointers, flags, chairs, drones, pets, smoke or gas canisters (including aerosols), dangerous or hazardous items of any description, unauthorized items for trading including but not limited to any goods or items using unauthorised event logos or brands, and any other item which in the sole opinion of the Organisers endangers public safety. The Organisers reserves the right to refuse entry to the Event or to eject anyone found to be in possession of any such item(s).
18. The following behaviour is expressly prohibited at the Event and Venue:
- Underage drinking
  - Alcohol cannot be brought into the Venue
  - Smoking
  - Unauthorised merchandising
- The Organisers reserves the right to remove any person participating in such prohibited activity from the Event and Venue.
19. The Event may be filmed and items used for internet streaming. By attending the Event you provide your consent to the use of your actual or simulated likeness in connection with the production, exhibition, advertising or exploitation of any film, video and/or audio recording of the Event or any element thereof in any media of whatever form throughout the world. You also agree to be filmed by police or security staff for the purpose of ensuring public security at the Event and preventing crime.
20. The Organisers shall not be liable for any loss, damage, cost or expense, except in the case of death or personal injury if due to any negligent act or omission on their part. Persons attending the Event are responsible for their own valuables and the Organisers will not be liable for any loss or damage to personal property brought to the Venue.
21. The terms and conditions set out herein shall be governed and construed in accordance with the laws and regulations of the Hong Kong Special Administrative Region of the People's Republic of China and are subject to the non-exclusive jurisdiction of the Hong Kong courts.
