- 2. Each tenant will only be allowed to register for 1 session.
- 3. All tickets cannot be re-sold. Anyone found to be reselling their tickets will have their tickets cancelled.
- 4. All tickets are unique to each attendee, and duplicate tickets will be refused.
- 5. To be admitted into the Venue and attend the Event, you must comply with the vaccination requirements in the Vaccine Pass scheme, and have received the third dose after 6 months from the second dose, or have received the second dose within 6 months from the first dose; only those holding an Exemption Certificate issued by a doctor will be exempted.
- 6. All persons wearing "compulsory quarantine" hand straps or Vaccine Pass holders with a Red and Amber Code will not be allowed to enter.
- 7. Upon arrival, all staff and guests are required to present a vaccination record and scan the LeaveHomeSafe App venue QR code. The Organisers reserve the right to refuse entry of any persons who do not comply with the requirement.
- 8. To enter the Venue and attend the Event you must wear a face mask or facial covering that covers the chin, mouth and nose.
- 9. The Organisers may implement crowd control measures based on the number of attendees.

- 10. You are required to follow the social distancing guidelines implemented by the Organisers.
- 11. The ticket you have reserved is for the Event and the Organisers reserve the right to alter or change the programme, line up and offerings without prior notification.
- 12. The Organisers reserve the right to cancel the Event at any stage, if deemed necessary in their sole opinion, or if circumstances arise which are outside their control, including but not limited to pandemic restrictions and adverse weather conditions.
